GENERAL CONDITIONS FUN FOREST – ADVENTURE PARK

1. Each participant must read these general conditions before entering the Park. By its signature, he (she) confirms to have read the rules and gives the guarantee to respect them. Regarding minor participants: the parents must take note of the rules to be respected and must inform the minors concerned before they enter the Park. By their signature, the parents guarantee to have read, understood and transmitted the rules to the minor participants. **Children under 14 years old must be accompanied by an adult.**
2. Entering Fun Forest is related to risks. Point n°7 determines the responsibility of Fun Forest.
3. The park is open to all visitors from 5 years old on, who do not suffer from a disease, of a psychic or physical problem, which could represent a danger to their own health or to others. People under the influence of alcohol, drug or medicine or any other substance are not authorized to enter the Adventure Park.
4. **The use of mobile telephones, cameras, video cameras is strictly prohibited in the park. Please leave any object which can represent a danger for yourself or others. Long hair must be tied back.**
5. **Each participant must listen till the end to the safety instructions before being able to take part to the activities in the Adventure Park.** All information and decisions of the organizer / instructor must be respected. We reserve ourselves the right to exclude from the park any person having made an infringement or any person not having complied with the safety requirements explained by the organizer / instructor. In the event of noncompliance with these rules, Fun Forest declines any responsibility in the event of damage or accident.
6. **The equipment lent by Fun Forest (helmet, harness, safety ropes with snap hooks) must be used in accordance with the instructions of the organizer / instructor. This equipment should neither be exchanged, nor be removed on the way and must be returned to the office after use. The snap hooks must always be fixed to the safety cable. During the changes, one of the snap hooks must always be fixed to the safety cable. It is strictly forbidden to undo both snap hooks at the mean time. The use of the wire rope must be exactly in conformity with the explanations of the organizer / instructor. In case of doubt, please ask him / her.**
7. **Fun Forest answers legally regarding physical injuries. Regarding pecuniary damages or material damages, Fun Forest answers only in the event of major negligence of the organizer / instructor. Fun Forest declines responsibility in case of damages that might be caused on clothings.**
8. Each worksop can be used only by one person at once. The platforms can support max. 3 people.
9. The management has the right to exclude people who are not respecting the rules of the Park. The management has also the right to bring modifications for technical or safety reasons (fire, storm, storm, etc). In this case, the entrance ticket is not refundable. **If a participant wishes to leave the park earlier or without finishing the course, the entrance ticket will not be refunded.**
10. Fun Forest has the right to use any photograph or film or for advertising or information matters.
11. Pictures or films in a purpose of advertising are strictly prohibited. In the event of nonrespect, Fun Forest has the right to claim interests.
